Japan visa application form – It is important to carefully readthrough all the questions and fully complete all forms in BLOCK CAPITALS with a BLACK PEN. All application forms MUST be printed single-sided.
Original, signed China passport Passport must have at least 6 months remaining validity on the date of travel and have at least 1 visa page clear of any markings.
Photo – One photograph, size 2 x 2 (taken within last 6 months).
Proof of Status – Original ILR card or other proof of resident status in the UK, this should be valid for more than 6 months after your return from Japan.
Bank Statement – Copies of original bank statements from the past 3 months (no online statements accepted).
Employment Letter – An original letter from your employer/school (on business letterhead, with contact details), stating that a leave of absence has been granted and that you will be returning to your current job. The Employment Letter must be addressed to Japan High Commission If you are self-employed, include a copy of your business license and tax return. If you are retired please submit proof of your retirement fund.
TRAVEL ITINERARY – Copy of round trip tickets or itinerary and copy of confirmed hotel reservations including name of the applicant, name and address of the hotel, duration of stay and schedule of stay (Japanese or English) for the proposed trip.
INVITATION LETTER — Copy of tourist voucher (invitation) issued by tourist company or hotel reservation in Japan.
